Product: Canadian Mild White Cheddar

1.0 Description:

The product is made from heat treated whole cows milk. The colour must be creamy white and uniform throughout the product possessing a close texture with firm, smooth body.

The block must be rectangular with no rounded edges and not mis-shaped.

2.0 Organoleptic:

Flavour: Typical Cheddar flavour, slight dairy, clean, no off notes (rancid, weedy, fruity, bitter, unclean.) Cheddar cheese exhibits characteristic seasonal variations in flavour and texture and continues to develop with age.

Texture: Smooth, closely knit and firm (not: weak, coarse, stiff, crumbly, acidy, corky, mealy, open or gassy.) Texture may be slightly broken down.

Aroma: Clean, slight dairy, no off aromas (unclean, fruity etc.)

3.0 Ingredients:

Whole Milk, Cheese Lactic Starter Culture, Animal Rennet, Salt
